I am a social worker with over 24 years experience in assisting children, individual adults, couples and families from diverse backgrounds with their mental health and wellbeing. From 1999 to 2009 I worked full time as a couple and family therapist working with complex couple and family issues including but not limited to communication difficulties, desire discrepancy, infidelity, family violence, step-parenting issues, the impact of mental health issues and substance abuse on relationships, and behavioural difficulties in children. I also provided clinical supervision to other family therapists. I have acted as a Child Consultant in Family Dispute Resolution. I was Lecturer-in-charge at ACU for the undergraduate unit Working with Families and Groups for several years. I was chair and co-writer for post separation parenting program Keeping Kids in Mind. From 2009 until early 2023 I worked full time at the Parramatta Registry of the now FCFCOA providing expert opinion to the Judiciary on issues such as family violence, resist/refuse dynamics, relocation, the impact of mental health and substance misuse on parenting, and the impact of parental conflict on children.
